**Eligibility:** Events 1 to 6 are open to all USATT members. No membership is required to play events 7, 8, and 9. Participant (events 1–6) must be able to show proof of current membership with the USATT. USATT membership can be renewed or purchased at the event.  
**Equipment:** 12 USATT/ITTF approved tables and 3-star Butterfly balls.  
**Entry Deadline:** Entry must be postmarked by **April 3, 2010** (received by 4/6/2010). Entries postmarked late will be accepted with a \$5 late fee or will be rejected based on available space.  
**Check-in:** Doors Open at 8:00AM. Check-in starts at 8:30. Participants are required to check in no later than 15 minutes prior to their event start time.

**Refunds:** A written request for a refund must be submitted. No refunds after April 3, 2010.

**Ratings:** 4/3 USATT ratings will be used for player final placement and seeding.

**Policies:** Event 9 requires current student ID and a USATT rating (if applicable) below 1000. There are 3 time sessions: 9:30am, 12:30pm, and 3:30pm. A player can play up to 3 events, one per time session.

If a player decides to play more than one event, the event in which the player earned the most points will be counted toward his/her SATTA Tour points (events 1-6).

Play will be conducted using the USATT Tournament Guide. All decisions of the tournament committee are final.

**Tournament Format:** All singles events are 4/5-player round robins. Top 2 players from each RR group advance to a single elimination bracket.

Unrated players in can not advance out of rated round robin unless a rating was assigned based on USATT League records. Players who arrive 15 minutes after his/her event start time will be defaulted.

All matches are best 3 out of 5 games to 11 points. The tournament committee reserves the right to modify format or cancel events and adjust prize money/trophy distribution if there are insufficient entries.
