Eligibility: Events 5-14 are open to all USATT members. Participant (events 1-11) must be able to show proof of current membership with the USATT. USATT membership can be renewed/ purchased at the event. Tournament Pass (\$10) is for one tournament only. Events 1-4 by invitation only. No membership is required to play events 12-15.

Equipment: USATT Sanctioned tables and Butterfly 3-star balls will be used.

Entry Deadline: Entry must be postmarked by **December 2, 2009** (received by 12/4/2009). Entries postmarked late will be accepted with a \$5 late fee or will be rejected based on available space. If event is full, you will be placed in the next highest event.

Check-in: Starts at 8:00AM . Participants are required to check in 15 minutes prior to their event.

Refunds: A written request for a refund must be submitted. No refunds after the draw is made and posted to the Web.

Ratings: Ratings received from the USATT will be used. Players can check their USATT rating online at www.usatt.org
Policies: Tournament committee re-

serves the right to modify or cancel events and/or prize money if there are insufficient entries. Play will be conducted using USATT rules and regulations. USATT dress code will be enforced. All decisions of the tournament director are final. **Tournament Format:** All events are 4/5-player round robins. Top 2 players from each RR advance. Unrated players can not advance out of rated round robin events unless a rating was assigned based on So. AZ USATT League records. Players who arrive 15 minutes after his/her event start time will be defaulted. All matches are best 3 out of 5 to 11 points games. Each 9:30AM event will be limited to a maximum of 8 players. Player can only enter one 9:30AM round robin event.
