The tournament is specifically designed for players who are working their way up from the lower ranks and want to participate in a relaxing, yet-competitive tournament against their like-talented peers. It's the perfect tournament for those wanting to get into the game – or have just gotten into or returned to the game – so they can gauge their level of play.

The finalists of each group will get their fees paid into the 10/31 USATT sanctioned SATTa Tour tournament.

It'll cover your \$15 entry fee and \$7 USATT rating fee. USATT membership/tournament pass fee is not included. No cash value.

Secure your spot in the tournament as soon as possible because slots will be limited to the first 10 in each of two groups.

Eligibility: Event is open to players of all skill levels. USATT membership is not required but can be renewed or purchased at the event. USATT players ranked U1300 are welcome to play in their level group.

Equipment: 8 USATT approved table tennis tables, DHS Olympic 3-star balls and barriers will be provided.

No sandpaper paddles are allowed. A spare paddle will be offered if you forgot to bring your own.

Entry Deadline: Entry must be received by **August 21, 2009**. Entries received late will be accepted or rejected based on available space. If event is full, you will be placed in the next highest event.

Check-in: Starts at 8:45AM. Participants are required to check in 15 minutes prior to their first event.

Refunds: A written request for a refund must be submitted. No refunds after entry deadline, 8/21/2009.

Ratings: This is recreational not-for rating tournament however your fair estimated level will be used for your placement in a free League play that will be held on Saturday, September 5th, 2009

Policies: Tournament committee reserves the right to modify or cancel events and/or prize money if there are insufficient entries. Play will be conducted using basic USATT rules and regulations. Registered players who arrive 15 minutes after his/her event start time will be defaulted.

All decisions of the tournament staff are final.

Tournament Format: All events are 5-player round robins. Top 2 players from each RR advance to finals.

All matches are best 3 out of 5 to 11 points games. Each 9:30AM event will be limited to a maximum of 10 players. Player can only enter one round robin event.
